

The Cabot Board of Selectpersons did meet as warned on 5 April 2006 at 7:00 p.m.

Attending were: William Walters, Ted Domey, Larry Gochey and Caleb Pitkin; Chair; Selectboard, Christopher Kaldor; Town Clerk - Treasurer.

Selectboard [SB] Agenda, copy attached hereto, reviewed and duly noted.

Caleb called the meeting to order at 7:05 p.m.

1. Agenda Item [AI] 1 - Larry moved to approve as printed the minutes of 22 March 2006; Ted seconded. No discussion, motion passed unanimously.

2. AI 2 – Public Comment - William Walters; Web Master submitted some post cards entitled *Quick Guide to Cabot Government* and other post card samples having to do with the Town Web Site; general discussion ensued. SB members will contact William with any suggestions for changes on post cards. No further public comment.

3. AI 3 - Administrative duties – Christopher submitted copies of two petitions; 1] “Now Come the undersigned legal voters of the town of Cabot and petition under 17 VSA 2661 (a) & (b), requesting the rescission of Article 5 voted at the Cabot School Meeting on March 7, 2006.” 2] “We the undersigned legal voters of the Town of Cabot hereby request that the Cabot Selectboard call a special meeting to have the voters reconsider the following article: Article 1. Shall the town of Cabot vote the sum of \$50,000 to purchase Ten acres of unimproved land, being the same, more or less, located on Vermont Route 215 South, for the purpose of procuring a site to locate a Town Highway Garage?” Selectboard received and reviewed petitions and will warn a Special Meeting to sign the Warning for a Special Town Meeting. Christopher submitted a dog complaint letter from Jeannine Greaves dated March 23, 2006 and a dog complaint letter from Tim White dated March 13, 2006; SB reviewed same. Christopher will forward copies to Jo Guertin; Animal Control Officer and initiate Ordinance for the Control of Dogs procedures following receipt of a complaint letter. Christopher submitted a MasterCard BusinessCard *Request for New Account* and *Businesscard Resolution Form for the Town of Cabot* from Chittenden Bank; SB reviewed same. Ted moved to authorize the BusinessCard *Request for New Account* and *Businesscard Resolution Form for the Town of Cabot* from Chittenden Bank for the Town of Cabot by the Town Treasurer; Larry seconded. No discussion, motion passed unanimously and SB members signed the *Resolution*

*Form.* Andy Luce; Fire Warden joined the meeting to present the SB members with the *Vermont Deputy Town Forest Fire Warden Appointment Form 2006*. Larry moved to sign the *Vermont Deputy Town Forest Fire Warden Appointment Form 2006* naming Walter Bothfeld Jr as Deputy Town Forest Fire Warden; Ted seconded. No discussion, motion passed unanimously and SB members signed the *Form*. No further administrative duties.

4. AI 4 – Caleb noted receipt of a letter of resignation from Robert Willcutts; he’s resigned his position as Lister effective 7 April 2006. No further correspondence.

5. AI 5 – No legal business.

6. AI 6 – Other business – No other business.

7. AI 7 – Larry moved to adjourn the meeting; Ted seconded. No discussion, meeting adjourned at 8:03 p.m.
